## **COLERNE VILLAGE HALL RISK ASSESSMENT**

The Management Committee decided to do a risk assessment of Colerne Village Hall to control risk to people who use the Hall and are involved in its maintenance and upkeep.

The Management Committee does not have a legal requirement to record the findings of this risk assessment as it has no employees. All the repair and maintenance work at the hall is carried out either by volunteers or, where appropriate by self-employed contractors, who have responsibility for their own health and safety, as well as for other issues, such as their hours of work and their financial and tax arrangements. The Committee has, however, decided that there are sound legal and business reasons to record the findings of this risk assessment and to take steps to ensure that they are brought to the attention of those using or working at the Hall.

The Chairman and Secretary followed the guidelines on the Health and Safety Executive website to produce this risk assessment.
